Re: Planning for End of Support for MS Windows Server 2003

As many of you are aware, every Windows product has a lifecycle. This lifecycle begins when a product is released and ends when it's no longer supported. End of Support (EOS) refers to the date when Microsoft no longer provides automatic fixes, updates, security patches, and online technical assistance. Microsoft will end extended support of all Windows Server 2003 products on July 14, 2015. This includes the following products:

- Microsoft Windows Server 2003 R2 Datacenter Edition (32-Bit x86)
- Microsoft Windows Server 2003 R2 Datacenter Edition with Service Pack 2
- Microsoft Windows Server 2003 R2 Datacenter x64 Edition
- Microsoft Windows Server 2003 R2 Datacenter x64 Edition with Service Pack 2
- Microsoft Windows Server 2003 R2 Enterprise Edition (32-Bit x86)
- Microsoft Windows Server 2003 R2 Enterprise x64 Edition
- Microsoft Windows Server 2003 R2 Standard Edition (32-bit x86)
- Microsoft Windows Server 2003 R2 Standard x64 Edition

Without Microsoft support, you will no longer receive vital security updates that protect your systems from harmful viruses, spyware, and other malicious software. Servers that are operating on any of the aforementioned products will not be safe for accessing the state data network or the internet past the EOS date. As such, please have your Windows Server 2003-based servers upgraded to either Windows Server 2008, Windows Server 2012 (preferred), or discontinue its use by July 1, 2015.

If you currently have any servers in your organization that are still running on Windows Server 2003, please send the following information to mason.tanaka@governor.alabama.gov no later than **November 30, 2014**. **Negative responses are required.**
